

Additional features include Marvin clad exterior/wood interior low-E glass windows, solid core interior wood doors, epoxy garage floors with built-in storage cabinets, and countertops. The dining room includes a wet bar and built-in cabinetry, while a bonus room features a wet bar, full fridge, and wine fridge.

The property offers a range of modern conveniences, such as Oelo permanent holiday lighting in the front, a whole-house Wi-Fi Water Flo valve, and Wi-Fi sprinkler control. The back patio is wired with 220V for a hot tub and water feature.
