Ramshorn Grazing Water Right Analysis

The Ramshorn Farm is located 8 miles north of Moore, Idaho. The farm has a total of thirteen privately owned irrigation water rights, two stockwater rights and one domestic water right. Irrigation water from the Mackay Reservoir was not evaluated in this analysis to determine if storage water is applicable to the Ramshorn Farm.

Irrigation Water Rights

There are four water rights on this farm currently in the name of Melvin Ellwein. All four of these water rights are supplied water from the Big Lost River. The water is delivered through the Burnett Ditch. The four water rights are allowed to irrigate 155.0 acres and their location are shown on the attached map in red.

Water right 34-228A, priority date 6/1/1884, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Water right 34-360C, priority date 6/1/1887, allowed diversion rate of 0.92 cfs (412 gpm) and the irrigation of 40.0 acres.

Water right 34-856G, priority date 4/30/1884, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Water right 34-14835, priority date 6/1/1894 and an allowed diversion rate of 0.80 (360 gpm). The allowed acres of irrigation under this water right was not identified by the Idaho Department of Water Resources.

There are ten water rights currently in the name of Ramshorn Grazing Assn Inc. Seven of the water rights receive water from the Big Lost River. The Big Lost River water rights are delivered through the Burnett Ditch. One water right is diverted from Jaggle Springs. There is one ground water right that diverts water from a ground water well on the farm. The ground water well is located in Township 06 North Range 26 East Section 17 NENESE.

Big Lost River water right 34-119B, priority date 4/22/1884, allowed diversion rate of 2.0 cfs (900 gpm) and the irrigation of 100.0 acres.

Big Lost River water right 34-213A, priority date 3/13/1887, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Big Lost River water right 34-223A, priority date 6/1/1884, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Big Lost River water right 34-225, priority date 6/1/1894, allowed diversion rate of 1.60 cfs (720 gpm) and the irrigation of 80.0 acres.

Big Lost River water right 34-227A, priority date 6/1/1899, allowed diversion rate of 1.20 cfs (540 gpm) and the irrigation of 40.0 acres. The allowed acres of irrigation under this water right was not identified by the Idaho Department of Water Resources.

Big Lost River water right 34-10540, priority date 4/30/1884, allowed diversion rate of 1.60 cfs (720 gpm) and the irrigation of 80.0 acres.

Big Lost River water right 34-10541, priority date 9/14/1884, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Jaggle Springs water right 34-215, priority date 6/1/1904, allowed diversion rate of 0.80 cfs (360 gpm) and the irrigation of 40.0 acres.

Ground water right 34-2479, priority date 7/27/1966, allowed diversion rate of 4.58 cfs (2056 gpm) and the irrigation of 327.0 acres. The 327.0 acres allowed by this ground water right can be irrigated anywhere within the combined 410.0 acres. Water from the ground water well is not allowed to irrigate the entire 410.0 acres. The location of the 410.0 acres are shown on the attached map in blue.

Domestic Water Right

Water right 34-10542 is a domestic ground water right with a 7/1/1977 priority date. This water right is limited to the diversion of 13,000 gallons per day and the irrigation of ½ acre of lawn associated with one residence.


Stockwater Water Rights


Water right 34-10543 is a ground water stockwater right with a priority date of 7/1/1884. This water right is limited to a diversion of 13,000 gallons per day or 400 head of stock animals.

Water right 34-13652 is a stockwater right with a priority date of 3/16/1923 that is delivered water from Pass Creek. The diversion of this water right is limited to 13,000 gallons per day.

Irrigation

A 2021 aerial imagery was used to map out the current locations of the water rights and to determine how many acres are being irrigated. In 2021, there was 498.0 acres irrigated. The irrigation water rights on this farm allow the irrigation of 565.0 acres. Which means that an additional 67.0 acres could be irrigated on this farm if the water from the Big Lost River is available. The irrigated area is identified on the attached map in solid light green.
