It is North Rim Road Association's understanding that the purpose of the gate is to minimize vehicular traffic from either association using the road system of the other association. This reduces wear and tear on the roads and limits liability issues for both associations. The access through the gate is allowed by emergency vehicles.

The North Rim Road Association does not have a copy of the key for the lock on the gate between North Rim Road and Mount Champion Drive. If Glacier View Road Association wants to provide you a key to have better access to your property the North Rim Road Association has no objections as long as the following conditions are met:

- 1. The gate shall remain locked at all times and is opened only for your personal use and shall not be used by contractors.
- 2. No other copy of the key is made available to others including contractors.
- 3. The access shall not blocked by your personal vehicle.
- 4. The key shall be returned to glacier View Road Association if the subject property is sold.
- 5. North Rim Road Association reserves the right to review, modify or revoke these conditions annually.
