







About This Property

A long, straight asphalt driveway passes agricultural fields before reaching a quiet oak grove that opens to an oasis with two homes. The 1974 house has 4 bedrooms, 3 bathrooms, and a basement workshop with 11-foot concrete ceilings, while the second home offers 3 bedrooms and 2 bathrooms. A barn and pond complete this 8.5-acre country retreat just minutes from town.

Land

This eight-acre property begins with a 660-foot asphalt driveway, lined on both sides by crop fields, creating a scenic approach to the homes. The 660 foot drive leads back into a grove of mature oak trees where the two houses, barn, and pond are tucked away. The setting offers both privacy and charm, with open ground for use and a stocked pond that adds to the land's appeal.









Improvements

Main Home- Spacious Custom-built 4 bedroom, 3 1/2 bath ranch house with over 2900 square ft living space. Spectacular deck views of a beautiful pond stocked with bass and bluegill fish. Masonry fireplace, radiant floor heat, 2 heat pumps HVAC systems, & wood-burning outdoor boiler. Spacious 2+ car attached garage. (810 sq ft,) Drive-in basement with 11 ft. high concrete ceilings, 2650 sq. ft. Plenty of room for workshop and any projects.

Second Home- Completely remodeled 3-bedroom, 1-bathroom, open floor plan house of approximately 1400 sq. ft. Large Front porch with spacious detached 2-car garage. Beautiful views out every window. Ideal for multigenerational living or rental income.

A 48×76 barn adds to the property, offering three levels with a basement, main floor, and partial second floor for storage or projects. Barn has approximately 9,600 Sqf. The stocked pond is the perfect spot to relax, fish, or just enjoy the view.

This property offers a rare mix of space, privacy, and versatility with room for family, hobbies, and outdoor enjoyment.









Recreation

Situated at 6914 Mensching Rd, Huntley IL, this property offers much more than its acreage — it's ideally placed for enjoying the outdoors. Adjacent you'll find Pleasant Valley Conservation Area, a massive McHenry County natural area spanning around 1,777–2,080 acres of woodlands, prairie, wetlands and savanna.

The property's existing features — including the large barn, spacious drive-in basement (ideal for gear, tack, etc.), open areas, and mature trees — set the stage for many kinds of recreational uses: horse boarding, hobby farm, riding, wildlife observation, fishing in the stocked pond, and more.

Add to that the proximity of Pleasant Valley for hiking, birding, nature walks, wildflower and wetland viewing, and you've got the best of both private and public outdoor options. Whether you want to ride on your own trails, explore nearby public nature areas, or combine both, this property gives you flexibility and access without long drives.
