AGENDA for MILL CREEK ASSOCIATION ANNUAL MEETING JANUARY 27, 2024

Mill Creek Association's Annual Members' Meeting was held on Saturday, January 27, 2024, from 10:00 a.m. to 1:00 p.m. It was a hybrid meeting, held both in-person at the Downtown Library in Fort Collins and via the Zoom online meeting platform.

IN ATTENDANCE

About 65 Mill Creek members representing 42 of 68 total voting members were present online and inperson representing 61% of the voting members. 34 votes were needed for a quorum. 15 voting members attended via Zoom and 27 members attended in-person.

MEETING NOTES

9:00 a.m. The Peterson Street Public Library meeting room was opened, and members began

arriving.

9:30 a.m. The online meeting platform was opened, and members began logging in.

10:20 a.m. Meeting starts (technical difficulties with the room size caused the meeting to be delayed

approximately 20 minutes)

Matt Perry called the meeting to order and welcomed everyone. Janet Hardy verified

that there was a quorum (at least 35 of 68 properties present).

The 2023 annual meeting minutes were shared on screen and reviewed. One question about 68 voting properties and the number was confirmed. A question was raised about the difference between voting members and dues paid for multi-owner properties. Laura Angelo answered and proceeded to vote.

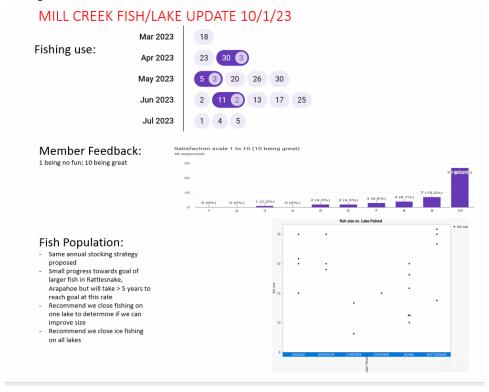

The 2023 Mill Creek Association annual meeting minutes were approved as written.

10:35 a.m. Matt spoke about the successes of this past year including the FishFest and chili cook-off. He thanked Ray and Sue for all the help they have provided over the past year. He thanked Kevin and Wendy Broiles for all their help with FishFest and the board for their support and dedication.

10:44 a.m. Fish/Lake update-Eric Bradley shared his report. Eric has provided Creel Surveys at each lake to report size, type and number of fish caught. His reports analyze these surveys to guide decisions about fish and lakes, and he requests that members fill one out when fishing! Questions about ice fishing and the possibility of two times a year fish stocking were discussed.



10:57 a.m. Dam Report-Stan Durham-Shared his report.

- 2022 Cheyenne Dam was repaired for \$46,000. This included \$36,000 for dam repair, and \$10,000 in dredging and willow clean-up.
- 2023 \$27,900 Special Assessment for Dam Repair, based upon 93 Memberships @ \$300/per membership. We did not have enough money in 2023 to repair any of the dams.
- 2024 \$27,900 <u>Proposed</u> 2024 Special Assessment, based upon 93 Memberships @ \$300/per membership.
 - o If we get this <u>Proposed</u> 2024 Special Assessment passed, we will hopefully be able to repair Arapahoe this summer with the 2023 assessment money and part of the 2024 assessment money. Dam consultants recommend that Arapahoe be the next lake to be repaired, because it is the next largest lake after Cheyenne that the fire departments draw from for firefighting.
 - Repair of Arapahoe Dam will hopefully still cost \$36,000 + potentially \$10,000 in dredging and willow clean-up. It could be less, or it could be more for dredging/willow clean-up. It depends upon what we find once we drain it.
 - Justin, the dam repair person, really wants to work with Mill Creek, and will try to hold his \$36,000 price, IF the material/equipment does not go up too much in price.
 - Any monies that are not used in 2024 on Arapahoe Dam will roll over into 2025, and we are hoping that we will have enough money to repair the next dam in 2025. This will only be possible if we continue at least the \$300/year special assessment.

Questions about the silt and dredging and what happens when we do the dam repairs. Unadjudicated water and the release. Beaver dam and beaver control.

Budget spent: \$1,595.91

- We purchased a <u>Bluetti</u> expansion battery and enhancer.
 The Hardy's donated a solar panel that we will connect the existing panels. In the spring of 2024, we will dig a larger hole and hook up the additional solar panel and battery expansion.
- Gate incident on 12/23/23. The person was identified, and it was reported to the LCSO. We are proposing an agreement with a neighboring property to access through their gate in the event of an emergency, such as a fire.

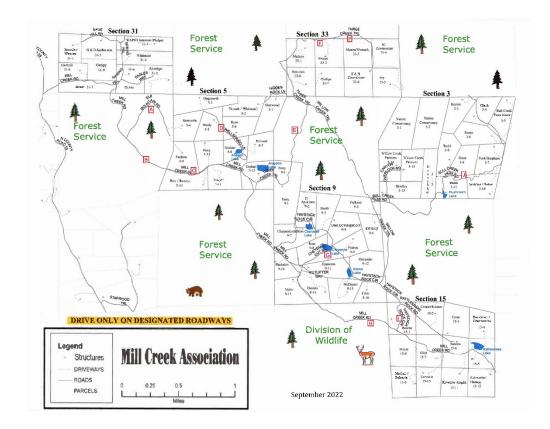

11:40 am-Derek Noland Roads Report

Spent additional funds this last year due to heavy rains and roads being washed out. Completed most of the items on the list. Completed jobs with notes in red.

- A. **Elk Mountain Road** Propose 1-2 loads of 1" rock starting at the fork and spreading uphill in 2 directions, towards the main road and up towards the Faubion place. -Completed this past year with 1" rock and got it cleaned up.
- B. **Mill Creek Rd** Big rock in the Forest Service section after Elk Mountain Rd Propose adding 1 load of Rd Base and leveling out to smooth out the road here. -1" road base added and smoothed out the rock.
- C. **Mill Creek Rd** Narrow area with South side drop off Propose cutting back a little on the North side (Faubion Prop) and widening/smoothing out the road over this stretch. This is a very narrow blind corner and a real pinch point for the Fire equipment to get through. Would require a couple of loads of Rd Base/1" rock.
- D. **Wellspring Ln** Narrow section of road heading NW through Ryan/Hardy properties Propose widening the road and clearing out brush on both sides. Hopefully this will not require materials, just man hours. –Widened road to 14' to allow emergency equipment in.
- E. **Three Creek Trail** S-curves/culvert Propose bringing in 1-2 loads of Rd base to help level/smooth out the road through here, also cleaning out the culvert if needed. -Culvert cleaned out and graded.
- F. Three Creek Trail along 2Bar7 property line (section 33) Propose adding 1 load of Rd base along here and widening the road where able. -Completed. Did not need to put road base

down.

- G. Cheyenne Cut Rd Propose adding 1 load of Rd base heading up the hill from the pond towards the top of the hill. Graded but still need to add road base and will work on the top of the hill. Went back 3 times and washed out.
- H. Mill Creek Rd Muddy/slimy area on D of W land between Sections 9 and 15 (closer to Bourne's place) Propose adding 1 2 loads of 1" rock and widening road as able. -added 1" rock and soaked it up.
- I. **Haystack Cut** Propose adding 1 load of 1" rock going up the hill from Bourne's place. -Need to add 1" rock this spring.
- J. **Bull Creek Pass Rd** muddy/slimy area through Todd/Hurst/Jenkins curves Propose 1 2+ loads of 1" rock to help shore up the road where it becomes a washout. -Took care of where it was all slimy and put down 1" rock.

Doug Busby asked about the 1" rock and had concerns about grading on top of it. Don Cooper expressed issues with a roads assessment and the reimbursement of funds to Lori Perry.

12:06 pm-Laura Angelo CWPP Report

Laura Angelo provided an overview of the Community Wildfire Protection Plan (CWPP) during the meeting, emphasizing its significance for Mill Creek to collaborate with neighboring communities. The primary goal is not merely to pursue potential grant funding but to ensure collective benefits for all members of the association.

To strengthen our ties, we engaged with various agencies, including Diamond Peak, Poudre River Ranch, Uthmans Ranch, Forest Service, and Nature Conservancy. Recognizing the potential for grant opportunities, we joined a larger group, as CWDG (Community Wildfire Defense Grant) requires a CWPP to be updated within 5 years to qualify for funding.

To explore grant possibilities, Kristin Leger volunteered to write a grant proposal in October 2023 for funding to engage a professional to complete the CWPP in 2024.

An informative slash pile workshop, organized in collaboration with the Ember Alliance, aimed to enhance fire awareness. The focus is on encouraging members to secure defensible space for improved fire protection.

We await confirmation of our qualification status and are eagerly anticipating the outcome. Laura's extensive 9-week course, sponsored by Coalitions and Collaboratives, has equipped her to lead the preparation of a comprehensive plan for submission by March 15th, the deadline for the Larimer County grant.

Highlighting community involvement and engagement, the plan aims to demonstrate Mill Creek's commitment to wildfire preparedness. Additionally, members can benefit from a Colorado tax credit for any work contracted for their property. This dollar-for-dollar tax credit against income taxes is a valuable incentive.

Notably, Mill Creek, with its natural breaks provided by roads and ponds, serves as a strategic component in the overall wildfire protection plan.
